We would like to inform you that in accordance with the provisions of data protection (Art 13 Para. 2 lit. e) GDPR), answering these questions is neither required by law or contractually. You are only providing the information in the interests of health protection for everyone on the shipyard premises.

### Information and rights on your data protection

#### For what purpose do we process your data

We only process your data in support of our measures to control the spread of an infectious disease (in this case COVID-19) to protect all persons on our shipyard premises.

#### What data do you record

Your first and last name, company, stay in a risk area during the past 10 days and whether you have flu-like symptoms including fever, cough or difficulties with breathing.

#### On what legal basis do we process your data

Art. 6 para. 1 lit a) GDPR or Art. 9 para. 2 lit. a) GDPR (as far as special personal data are concerned). You give us your consent to process personal data for the specific purpose.

#### Who are the recipients of your data

Your data will be forwarded to the named supervisor of the company for you, to the security service commissioned by us, the Blohm + Voss fire brigade and, in emergencies, to the emergency services.

#### How long do we keep your data

This completed questionnaire and data contained will be destroyed after 6 weeks.

#### Revocation

You may revoke your consent to providing personal data at any time and with immediate effect. If you elect to withdraw your consent, the legality of the data processing carried out up to that point will not be affected.

#### As the person concerned, you have the right:

- To request the confirmation of your personal data being processed; In this case, you have the right to obtain information about this personal data per Art. 15 GDPR.
- To immediately request the correction of personal data concerning you and the completion of personal data, per Art. 16 DSGVO.
- That your personal data will be deleted immediately if one of the reasons listed in Art. 17 GDPR applies.
- To request a restriction of processing if one of the requirements listed in Art. 18 GDPR is given.
- That we transfer your data to other entities on your request per Art. 20 DSGVO
- To object to the processing of your personal data at any time. We will then no longer process your personal data unless we can demonstrate compelling legitimate reasons that remain within your interests, rights and freedoms or the processing serves to assert, exercise or defend legal claims per Art. 21 DSGVO.
- To lodge a complaint with a supervisory authority if you believe that the processing of your personal data violates GDPR, specifically Art. 77 GDPR. You can exercise your right with the supervisory authority in the member state of your residence, your place of work or the place of the alleged violation as applicable. The responsible supervisory authority in Hamburg is the Hamburg representative for data protection and freedom of information.
